A seminar on some of the main theories of/issues in global justice in recent political thought. Part I (7 weeks) concerns distributive justice, introducing cosmopolitan and nationalist perspectives. Parts II and III (2 weeks each) concern retributive and reparative justice respectively.

Assignments:

1. 4206g: an essay, 12-15 pages, due April 11, worth 70%. Late penalty 2% per day. The essay should be on one of the week's topics, drawing on the readings for that week plus one other source to be discussed with the instructor. 9762b/9121b: same, but the essay should be 15-20 pages in length and should discuss two other sources to be discussed with the instructor.
2. 4206g/9762b/9121b: a weekly one-page (single-spaced) report summarizing what you take to be important in the set readings, to be handed in at the seminar. There is no mark for this assignment, which is simply intended as seminar preparation, but students who fail to hand in at least 8 reports on time during the term will not be eligible to receive a participation mark.
3. Participation mark, 30%. This is a seminar course and it works only if everyone does their best to contribute to discussion. The general expectation is that no student will let two weeks go by without making a contribution. Feel free to introduce questions about aspects of the readings that puzzle (or annoy) you.
