Politics 3215G – History of Political Theory

This course surveys classic works in the history of political theory. Key themes include the bases of political authority and political obligation, the nature and defence of individual rights, the idea of a social contract, the meaning and status of equality, the value of individual liberty, and the critique of liberal democracy and capitalism. The course aims to identify and evaluate the arguments in these works and consider their relevance for us today. The authors covered in this year's version of the course are Jean-Jacques Rousseau, John Stuart Mill, Harriet Taylor Mill, and Karl Marx.

By the end of the course, students will be able to:

- (1) Describe competing answers to the question, 'How could political power be legitimate?', and understand the historical development of approaches to this question,
- (2) Identify and assess the arguments for and against specific approaches to political thought, including social contract, utilitarian, feminist, and socialist,
- (3) Understand the main arguments for and against rights to speak, rights to participate in political decision-making, and rights to property,
- (4) Explain some of the main defences and critiques of liberal approaches to politics.

The late, great scholar, Jonathan Bennett, published excellent modernized versions of Jean-Jacques Rousseau's Social Contract and John Stuart Mill's On Liberty and The Subjection of Women. They are available for free at earlymoderntexts.com. Further excerpts from Rousseau, Harriet Taylor Mill, and Karl Marx will be available on the course Brightspace site.

How Your Final Mark is Determined

15%: Attendance

45%: 2,000-word Essay, 5-6 pages, double-spaced (Due by 4:00 pm on Thursday October 10, 2024)

40%: In-Person Final Exam (during December final examination period)

15% Attendance

Students must attend all classes except when there are medical or compassionate reasons. Students are encouraged to participate regularly by asking a question or making a point about the readings.

45% Essay: 2,000 words, 5-6 pages, Word document, double-spaced, 12-point. The Essay must be submitted, via Brightspace, by Thursday October 10th, 2024 at 4:00 pm. Late essays are subject to a penalty of 2% per day.

Here is the essay assignment:

With specific reference to Jean-Jacques Rousseau's Discourse on the Origin of Inequality and The Social Contract, along with Robert Wokler's Rousseau, write an essay on the following two-part question: (i) Describe Jean-Jacques Rousseau's main claims and supporting arguments about inequality; (ii) Does Rousseau's Social Contract successfully defend the idea of a society of free and equal citizens?

During the final examination period in December 2024, students will write an In-Person Final Exam.

APPENDIX TO UNDERGRADUATE COURSE OUTLINES DEPARTMENT OF POLITICAL SCIENCE

Prerequisite checking - the student's responsibility

"Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites."

Essay course requirements

With the exception of 1000-level courses, most courses in the Department of Political Science are essay courses. Total written assignments (excluding examinations) will be at least 3,000 words in Politics 1020E, at least 5,000 words in a full course numbered 2000 or above, and at least 2,500 words in a half course numbered 2000 or above.

Use of Personal Response Systems ("Clickers")

"Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence,
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence."

PLAGIARISM*

In writing scholarly papers, you must keep firmly in mind the need to avoid plagiarism. Plagiarism is the unacknowledged borrowing of another writer's words or ideas. Different forms of writing require different types of acknowledgement. The following rules pertain to the acknowledgements necessary in academic papers.

A. In using another writer's words, you must both place the words in quotation marks and acknowledge that the words are those of another writer.

You are plagiarizing if you use a sequence of words, a sentence or a paragraph taken from other writers without acknowledging them to be theirs. Acknowledgement is indicated either by (1) mentioning the author and work from which the words are borrowed in the text of your paper; or by (2) placing a footnote number at the end of the quotation in your text, and including a correspondingly numbered footnote at the bottom of the page (or in a separate reference section at the end of your essay). This footnote should indicate author, title of the work, place and date of publication, and page number.

Method (2) given above is usually preferable for academic essays because it provides the reader with more information about your sources and leaves your text uncluttered with parenthetical and tangential references. In either case words taken from another author must be enclosed in quotation marks or set off from your text by single spacing and indentation in such a way that they cannot be mistaken for your own words. Note that you cannot avoid indicating quotation simply by changing a word or phrase in a sentence or paragraph which is not your own.

B. In adopting other writers' ideas, you must acknowledge that they are theirs.

You are plagiarizing if you adopt, summarize, or paraphrase other writers' trains of argument, ideas or sequences of ideas without acknowledging their authorship according to the method of acknowledgement given in 'A' above. Since the words are your own, they need not be enclosed in quotation marks. Be certain, however, that the words you use are entirely your own; where you must use words or phrases from your source, these should be enclosed in quotation marks, as in 'A' above.

Clearly, it is possible for you to formulate arguments or ideas independently of another writer who hasexpounded the same ideas, and whom you have not read. Where you got your ideas is the important consideration here. Do not be afraid to present an argument or idea without acknowledgement to another writer, if you have arrived at it entirely independently. Acknowledge it if you have derived it from a source outsideyour own thinking on the subject.

In short, use of acknowledgements and, when necessary, quotation marks is necessary to distinguish clearly between what is yours and what is not. Since the rules have been explained to you, if you fail to make this distinction your instructor very likely will do so for you, and they will be forced to regard your omission as intentional literary theft. Plagiarism is a serious offence which may result in a student's receiving an 'F' in acourse or, in extreme cases in their suspension from the University.
